The Concept of Institute Interaction Cell

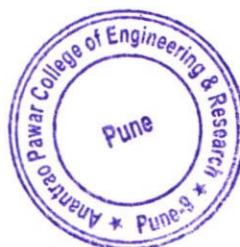

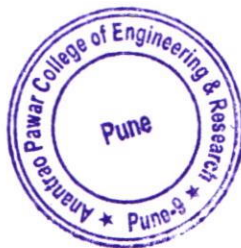
Objectives of Institute Interaction Cell
