**Anti-Ragging Squad Committee  
Academic Year: 2022 - 23**



**Objectives:**

- The anti-ragging squad is formed and is headed by a senior faculty member of the institute. The students at the entry-level sign an affidavit and submit to the University about non- involvement in ragging activities. Anti-ragging Squad makes sure that there are no instances of ragging anywhere on the campus and hostel.
- To prohibit, prevent and eliminate the scourge of ragging including any conduct by any student whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or undisciplined activities by any student.
- To monitor, direct and oversee the functions and performance of the Anti-Ragging Squads in prevention and curbing of ragging in the institution.

**Policies:**

- Displaying anti-ragging signs: Ensuring that anti-ragging instructions are displayed in prominent locations on campus
- Conducting regular checks: Creating a duty chart and regularly checking for ragging in areas such as classrooms, buses, canteens, and grounds
- Conducting surprise checks: Carrying out surprise checks in areas where ragging is likely to occur
- Reporting incidents: Informing the chairman of the squad if any incidents are noticed

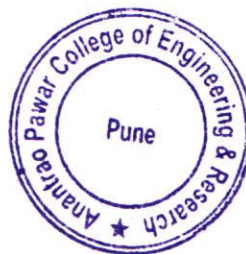
- Educating students: Using various methods to educate students about ragging and the punishments associated with it
  - Maintaining records: Keeping a duty attendance register for squad members and their duties
- Collecting student information: Collecting updated lists of students, including their phone numbers and addresses

**Role, Function and Responsibility:**



1. Preventing and prohibiting ragging in educational institutions.
2. Ensuring a safe and conducive environment for students.
3. Investigating ragging complaints and taking swift action.
4. Providing support and counseling to victims.

**Major Duties of Anti-Ragging Squad**

- It shall be the duty of the Anti-Ragging Squad to be called upon to make surprise raids on hostels, and other places vulnerable to incidents and having the potential for ragging and shall be empowered to inspect such places.
- It shall also be the duty of the Anti-Ragging Squad to conduct an on-the-spot enquiry into any incidents of ragging referred to it by the Head of the institution or any member of the faculty or any member of the staff or any student or any parent or guardian or any employee of a service provider or by any other person, as the case may be; and the enquiry report along with recommendations shall be submitted to the Anti-Ragging Committee for action. Provided that the Anti-Ragging Squad shall conduct such enquiry observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student or students accused of ragging and other

witnesses to place before it the facts, documents and views concerning the incidents of ragging, and considerations such other relevant information as may be required.

**Mechanism:**



On receipt of the recommendation of the Anti-Ragging Squad or on receipt of any information concerning any reported incident of ragging, the Head of college shall immediately determine if a case under the penal laws is made out and if so, either on his own or through a member of the Anti-Ragging Committee authorized by him in this behalf, proceed to file a First Information Report (FIR), within twenty four hours of receipt of such information or recommendation, with the police and local authorities, under the appropriate penal provisions relating to one or more of the following, namely;

- Abetment to ragging;
- Criminal conspiracy to rag;
- Unlawful assembly and rioting while ragging;
- Wrongful restraint;
- Public nuisance created during ragging;
- Wrongful confinement;
- Violation of decency and morals through ragging;
- Use of criminal force;

Depending upon the nature and gravity of the offence as established the possible punishments for those found guilty of ragging at the college level shall be any one or any combination of the following:-

- Cancellation of admission.
- Suspension from attending classes
- Withholding/withdrawing scholarship/fellowship and other benefits.
- Debarring from appearing in any test/examination or other evaluation process.
- Withholding results.

Suspension/expulsion from the hostel.

Provided that the Head of the college shall forthwith report the occurrence of the incident of ragging to the District Level Anti-Ragging Committee and the Nodal officer of the affiliating University.

Provided further that the college shall also continue with its own enquiry initiated under clause 9 of UGC Regulations and other measures without waiting for action on the part of the police/local authorities and such remedial action shall be initiated and completed immediately and in no case later than a period of seven days of the reported occurrence of the incident of ragging.
